Collection of your personal information

We will always tell you before we collect any Personal Information and inform you of the - purpose of the collection. “Personal Information” is any information that can be used to identify an individual, and may include, but is not limited to, name, email address, postal or other physical address, credit or debit card number and other information required to provide a service, deliver a product, or carry out a transaction you have requested. Some of the reasons we collect your Personal Information include:

Uses of your personal information

We will only use your Personal Information in the way we specified when it was collected. We will not subsequently change the way your Personal Information is used without your consent. Some of the ways we may use your Personal Information include:

- To provide customer feedback and support.
- To provide marketing or promotional activities on the soniclab.hu website. Personal Information may be collected to administer those programs.
- To meet contract obligations.

Sharing your personal information

We do not sell or rent your Personal Information to third parties for marketing purposes. We may share your Personal Information within Sonicláb Elektronika Kft. for purposes of data processing or storage.

We may also share your Personal Information with business partners or contractors in order to provide a requested service or transaction, including processing orders, processing credit card transactions, hosting websites and providing customer support. We only provide these third parties with the minimum amount of Personal Information necessary to complete the requested service or transaction, and the third parties are not permitted to use your Personal Information except for limited purpose of completing the requested service or transaction. We may respond to subpoenas, court orders, or legal process by disclosing your Personal Information and other related information, if necessary. We also may choose to establish or exercise our legal rights or defend against legal claims. We may collect and possibly share Personal Information and any other additional information available to us in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Sonicláb Elektronika Kft.'s terms of use, or as otherwise required by law.

While navigating Sonicláb Elektronika Kft.'s web site you may be directed to content or functionality that is hosted by a third-party supplier, not on sonicláb.hu. This is typically done to organize online payments. When information is collected on behalf of Sonicláb Elektronika Kft. exclusively, Sonicláb Elektronika Kft.'s privacy policy will be referenced on the site and will govern how your information is used. For other, non-Sonicláb Elektronika Kft. sites, the site owner's privacy policy will be referenced. It is Sonicláb Elektronika Kft.'s practice to require such suppliers to handle information in a manner consistent with Sonicláb Elektronika Kft.'s privacy and security policies.

We will ask for your consent before we use or share your information for any purpose other than the reason you provided it or as otherwise provided by this policy. In order to let us know your preferences, we will require an action on your part, such as checking the appropriate option, to indicate your consent.

Security of your personal information

Sonicláb Elektronika Kft. is committed to protecting the Personal Information you share with us. We utilize a combination of industry standard security technologies, procedures and organizational measures to help protect your Personal Information from unauthorized access, use or disclosure.

When we transfer sensitive personal data (for example, credit card information) over the Internet, we protect it using Secure Sockets Layer (SSL) or Transport Layer Security (TLS) encryption

technology. While we strive to protect your Personal Information, we cannot ensure the security of the information you transmit.

Cookies

Like many websites, Soniclab Elektronika Kft. uses technologies, such as cookies and web beacons, which allow us to make your visit to our website easier, more efficient and more valuable by providing you with a customized experience and recognizing you when you return.

A cookie cannot read personal data off your hard disk or read cookie files created by other sites; indeed, the only Personal Information a cookie can contain is information you supply yourself. Accepting the cookies used on our website may give us access to information about your browsing behavior, which we may use to personalize your experience and track user traffic patterns, and to merge this info when you register. We do this in order to determine the usefulness of our website information to our users and to see how effective our navigational structure is in helping users reach that information. You may browse most of Soniclab Elektronika Kft.'s website without accepting cookies from Soniclab Elektronika Kft.; however, some website functionality may be lost by disabling cookies on your computer. Other Soniclab Elektronika Kft. web pages, particularly those which require a login and password, require cookies and cannot be used when you have disabled cookies in your browser. In addition, Soniclab Elektronika Kft. uses web beacons in conjunction with cookies to understand user behavior. Web beacons are simply a convenient way of gathering basic statistics and managing cookies, and do not give away any extra information from your computer. Turning off your browser's cookies will prevent web beacons from tracking your specific activity.

If you prefer not to receive cookies while browsing our website or via HTML-formatted emails, you can set your browser to warn you before it accepts cookies or refuse the cookie when your browser alerts you to its presence. You can also refuse all cookies by turning them off in your browser.

Data retention

Soniclab Elektronika Kft. will not retain your Personal Information longer than is necessary to fulfill the purposes for which it was collected or as required by applicable laws or regulations.

Children's privacy
